2. There is a five fish limit.
3. All fish are to be at least 12" in length.
4. Fish are to be caught in legal sporting manner and only artificial lures are to be used.
5. This is a **catch and release** tournament.
6. All Louisiana wildlife rules and regulations must be followed; any disregard will be disqualified.
7. No alcoholic beverages or drugs during tournament hours.
